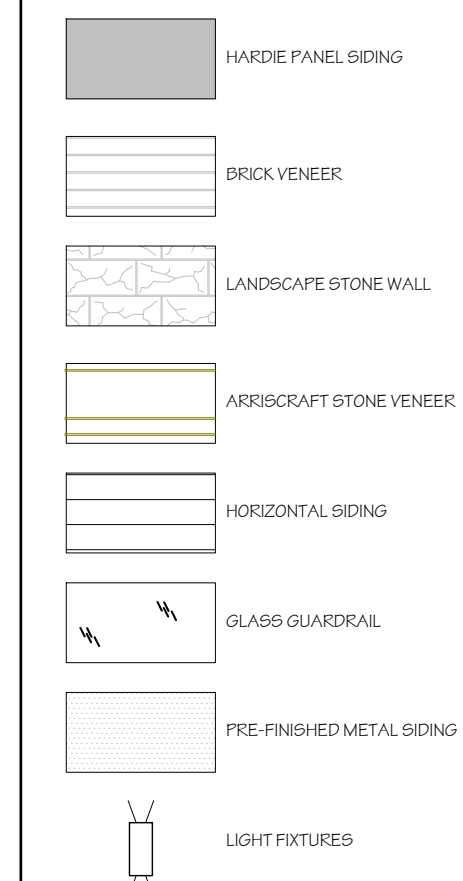


1 WEST ELEVATION
