Addendum To Report: Phase One Environmental Site Assessment – Northeast Part of 1900 Cyrville Road, Ottawa, Ontario, dated March 3, 2026, Prepared by Stantec Consulting Ltd. for Costco Wholesale Canada Ltd. (the “2026 Phase One ESA Report”)  
Reference: City of Ottawa – Historical Land Use Inventory (HLUI) Response & Results

*This addendum is to be read with and constitutes part of the 2026 Phase One ESA Report.*

## Background

A Phase One ESA for the Northeast Part of 1900 Cyrville Road, Ottawa, Ontario (the “Site” or “Phase One Property”) was completed by Stantec Consulting Ltd. (Stantec) for Costco Wholesale Canada Ltd. (Costco) in general accordance with Ontario Regulation (O. Reg.) 153/04, as amended. The results were summarized in the 2026 Phase One ESA Report.

An HLUI request was submitted to the City of Ottawa (City) on February 12, 2026. No response had been received when the 2026 Phase One ESA Report was issued. The City’s HLUI response and database results (HLUI Area Features and HLUI Point Features, summarized in Table 1 and Table 2, respectively), received on March 16, 2026, are enclosed with this addendum.

## HLUI Results

Stantec’s review of the HLUI response letter and database results identified no pertinent information for the Phase One Property. An Environmental Risk Management Area (ERMA) was identified within the Phase One Study Area in the HLUI database. The ERMA is located within the Cyrville Road right-of-way (ROW) on the adjacent east of the Site.

The City noted that soil and/or groundwater within the Cyrville Road right-of-way may contain petroleum hydrocarbons (PHCs) related to historical operations of the former Laidlaw Bus Company at 1901 Cyrville Road (formerly 1500–1550 Innes Road), including a maintenance facility and fuel outlet on the adjacent east property (previously identified potentially contaminating activities (PCA-3a and PCA3b). The City recommended special consideration for any soil excavation or groundwater management in this off-site ROW area.

## Conclusion

The review of the HLUI database did not identify additional on-site or off-site PCAs that may contribute to areas of potential environmental concern at the Phase One Property. Based on the HLUI review findings, the conclusions of the 2026 Phase One ESA Report remain the same, and there are no changes to the Phase One Conceptual Site Model presented in the 2026 Phase One ESA Report.

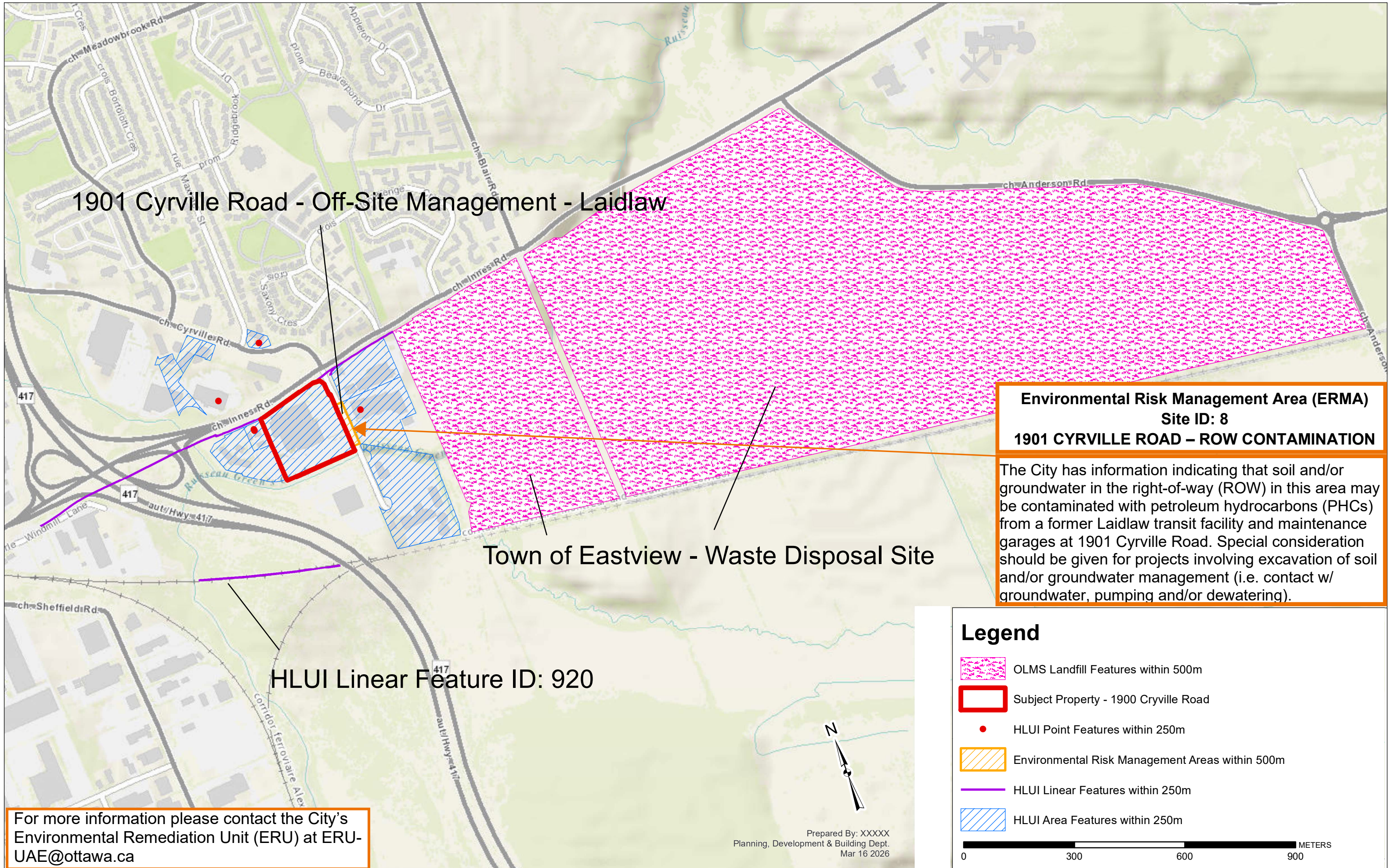

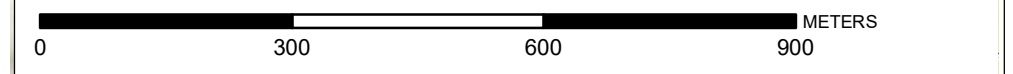
